1. What information do we collect?

We collect information from you when you visit our service, register, place an order, subscribe to our services, respond our survey or fill out a form.

- Name/Username
- Email addresses
- Phone number
- Age
- Password
- Data usage

We also collect information from mobile devices for a better user experience, although these features are completely optional:

- Location (GPS): Location data helps to create an accurate representation of your interests, and this can be used to bring more targeted and relevant ads to potential customers.
- Phonebook (contact list): your contacts list allows our service to be much easier to use by the user since accessing your contact from the app makes you save tons of time.

2.When do we use customers information from third parties?

We receive some information from the third parties when you contact us. For example, when you submit your email address to us to show interest in becoming our customer, we receive information from the third party that provides automated fraud detection services to us. We also occasionally collect information that is made publicly available by you on social media websites. You can control how much of your information social media website make public by visiting these websites and changing your privacy settings.

3. Do we share the information we collect with third parties?

We may share your information that we collect, both personal and nonpersonal, with the third parties such as advertisers, contest sponsors, promotional and marketing partners, and others who provide our content or whose services we may think interest you. we may also share it with our current and future affiliated companies and business partners, and if we are involved in a merger, asset sale or other business reorganization, we may also share or transfer your personal and nonpersonal information to our successor-in-interest. We may engage trusted third-party service providers to perform functions and provide services to us, such as hosting and maintaining our servers and our service, database storage and management, email management, storage marketing, credit card processing, customer service and fulfilling orders for products and services you may purchase through our service. We will likely share your personal information and possibly some non-personal information with these third parties to enable them to perform these services for us and for you.

We may share portions of our log file data, including IP addresses, for analytical purposes with third parties such as web analytics partners, application developers and ad networks. If your IP address is shared, it may be used to estimate general location and other technographics such as connection speed, whether you have visited the service in a shared location, and type of device used to visit the service. They may aggregate information about our advertising and what you see on the service and then provide auditing, research and reporting for us and our advertisers.

We may disclose personal and non-personal information about you to government or law enforcement officials or private parties as we, in our sole discretion, believe necessary or appropriate in order to respond to claims, legal process (including subpoenas), to protect our rights and interest or those of a third party, the safety of the public or person, to prevent or stop any illegal, unethical, or legally actionable activity, or to



otherwise comply with applicable court orders, laws, rules and regulations.

4. Where and when is information collected from customers and end users?

We will collect personal information that you submit to us. We may also receive personal information about you from the third parties as described above.

5. How do we use your email address?

By submitting your email address on our service, you agree to receive emails from us and you also agree to allow us to use your email address for customer audience targeting sites, where we display custom advertising to specific people who have opted in to receive communications from us.

6.Could my information be transferred to other countries?

We are incorporated in Singapore. Information collected via our application, through direct interaction to you or from use of our help services may be transferred from time to time to our offices and personnel, or to third parties located through world and may be viewed and hosted anywhere in the world. You voluntarily consent to the transborder transfer and hosting of such information.

7.Is the information collected through our service secure?

We take precaution to protect the security of your information, we have physical, electronic, and managerial procedures to help safeguard, prevent unauthorized access maintain data security and correctly use information. However, neither people nor security system are foolproof including encryption systems in addition people can commit international crimes, make mistakes or fail to follow policies. Therefore, while we use reasonable efforts to protect your information, we cannot guarantee its absolute security. If applicable law imposes any nondisclaim able duty to protect your personal information, you agree that intentional misconduct will be the standards used to measure our compliance with that duty.

8. How long do we keep your information?

We keep your information as long as we need it to provide services to you and fulfill the purposes described in this policy. This is also the case for anyone that we share your information with and who carries out our services on our behalf. When we no longer need to use your information and there is no need for us to keep it, we will either remove it from our systems or depersonalize it so that we can't identify you.

9. How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you enter or access your personal information in our application. We offer the use of a secure server. All supplied sensitive information is transmitted via secure socket layer (SSL) technology and then encrypted into our secure system only to be accessible by authorized personnel. We cannot however warrant absolute security of any information you transmit to us or guarantee that



your information on the service may not be accessed, disclosed, altered or destroyed by a breach of any of our physical, technical or managerial safeguards.

10.Sale of Business

We reserve the right to transfer information to a third party in the event of a sale, merger or other transfer of all or substantially all of the assets of us or any of its corporate affiliate to which the service relates, or in the event that we discontinue our business or file a petition or have filed against us a petition of bankruptcy, reorganization or similar proceeding, provided that the third party agree to adhere to the terms of this privacy policy.

11.Your consent

By using our service, registering an account on Tyr rewards, you consent to this privacy policy.

12.Links to other applications

This privacy policy applies only to the services. The service may contain install links of other applications not owned, operated or controlled by us. We are not responsible for the content, accuracy, or opinion expressed in such applications. And such applications are not investigated, monitored or checked for accuracy or completeness by us. Please remember that when you use a link from our service of another application, our privacy policy is no longer in effect.



13.Cookies

We use cookies to identify the areas of our application you have visited. We use cookies to personalize the content that you see on our application. However, if you disable cookies, you may not be able to access functionality of our application correctly. We never place personally identifiable information in cookies.

14.Advertising

Advertising keeps us and many of the application and services you use free of charge. We work hard to make sure that ads are safe, unobtrusive, and as relevant as possible.

15. Cookies for Advertising

Cookies help to make advertising more effective. Without cookies, it's really hard for an advertiser to reach its audience, or to know how many ads were shown and how many clicks they received.

16.Kids' Privacy

We do not address anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13. If you are a parent or guardian and you are aware that your child has provided us with personal information please contact us, we become aware that we have collected personal data from anyone under age of 13 without verification of parental consent. We take step to remove that information from our servers.

19. Information about General Data Protection Regulation (GDPR)

GDPR is data protection law for Eu residents which regulates how European residents' data shall be used by the companies. GDPR adds new requirements regarding how companies should protect individuals' personal data that they collect and process. GDPR also imposes greater fines for the breach.

We may be collecting and using information from you if you are from the European Economic Area (EEA). We collect data to fulfill certain purposes and we no longer held it if it is not necessary for our purposes. People covered under GDPR can request for update, delete, restrict data any time they want.
